- In case of expiration of the guarantee of the Brown Card ECOWAS, the policy-holder will have to obtain a new compulsory guarantee of civil liability.
- During its period of validity, the Brown Card ECOWAS has to constitute an assumption of proof of the existence of an insurance policy.
